If you are a parent, we insist that you ask your coach about your daughter's correct information being submitted for your team roster. Note: While this event does not require the NEW NCAA Coaches Certification numbers, we are asking that if you are planning on competing during the July Division 1 Observation period, ALL BENCH persons must have an NCAA number. If you do not, please go to their site (or the USJN registration site) and get your number for later this summer. Both coaches (all must have NCAA numbers in the July period) will receive USJN Event Coaches Bands for entry and clearance to coach on the team bench.
